TITLE: Resolution authorizing Bath Police Chief Chad Mullen to appoint Part-time Police Officer Ashley Emo to the position of "Temporary Full-Time Police Officer."

WHEREAS, the Bath Village Chief of Police has informed the Bath Village Board of Trustees that effective, Tuesday, April 27, 2015, two (2) full-time uniformed police officers have been out for an undetermined amount of time on transitional duty and this staff shortage will have a significant impact on the police department.

WHEREAS, Part-time Police Officer Ashley Emo will be appointed to the position of “Temporary Full-Time Police Officer”, effective Tuesday, April 27, 2015, to cover the shift of a full-time police officer that is anticipated to be out on transitional duty for an undetermined amount of time and Officer Emo will remain in that position for the duration of the full-time police officer’s absence up to a year, whichever is first.

WHEREAS, during the tendency of Emo’s temporary full-time position, she shall enjoy all rights, benefits and privileges of a full-time bargaining unit member.

WHEREAS, Emo understands and accepts that this position is a temporary full-time position and will terminate in three months.

BE IT RESOLVED, that the Village of Bath Board of Trustees hereby appoints Part-time Police Officer Ashley Emo to the Temporary Full-time Position of Police Officer, consistent with the stipulations of Steuben County Civil Service Rules and Regulations.

TITLE: Appointment of Jesse A. Little as Part-time Police Officer for the Village of Bath to fill the last vacancy.

WHEREAS, the Bath Board of Trustees had previously voted on a resolution for the need to fill eight part time police officer position in an effort of keeping police department over-time to manageable levels.

WHEREAS, the Bath Village Chief of Police, is recommending to the Board that Jesse A. Little be appointed to the position of part-time police officer commencing Tuesday April 14, 2015;

WHEREAS, Jesse A. Little currently meets all the Municipal Police Training Council's requirements as a police officer;

WHEREAS, Jesse A. Little is currently at the Southern Tier Law Enforcement Academy and he will be responsible for all costs associated with the Basic Course for Police Officers, located at Corning Community College;

WHEREAS, the police department has conducted a background investigation and determined Jesse A. Little's suitability as a part-time police officer for the Village of Bath;

WHEREAS, Jesse A. Little will be compensated pursuant to the collective bargaining agreement between the Village of Bath Board of Trustees and the Bath Police Benevolent Association;

WHEREAS, all new part-time police officer hires for the Village of Bath remain on a probationary period not to exceed 18 months from the date of appointment, Jesse A. Little's probationary period will commence on Tuesday, April 14, 2015;

BE IT RESOLVED, that the Village of Bath Board of Trustees is hereby appointing Jesse A. Little, effective Tuesday, April 14, 2015 to the position of Part-time Police Officer contingent on the aforementioned stipulations.
