TITLE: Appointment of Christian Zawko as Part-time Police Officer for the Village of Bath.

WHEREAS, the Bath Village Chief of Police had previously announced the need to hire part-time police officers in an effort of having sufficient personnel to cover vacations and sick leave in order to keep police department over-time to manageable levels.

WHEREAS, the Bath Village Chief of Police, Colin Taft, with approval of the Village Board, is authorized to maintain up to nine (9) part-time police officer positions, and is recommending that the Bath Village Board of Trustees appoint Christian Zawko effective January 22, 2024, to the position of Part-time Police Officer contingent upon the following:

- Satisfactorily passing the background investigation conducted by the Bath Village Police Department.
- Satisfactorily passing the psychological examination for employment
- All costs (tuition, lab fees, etc.) associated with the Basic Course for Police Officers at the Southern Tier Law Enforcement Academy, located at Corning Community College are the responsibility of Christian Zawko.
- The Village will compensate, pursuant to the collective bargaining agreement with the Bath Police Benevolent Association, only those hours worked during Supervised Field Training and hours assigned to him after successfully completing the Basic Course for Police Officers.
- Christian Zawko will remain on a probationary period not to exceed 18 months from the date of appointment.

BE IT RESOLVED, that the Village of Bath Board of Trustees is hereby appointing Christian Zawko to the position of Part-time Police Officer, contingent on the aforementioned stipulations and said appointment shall be effective January 22, 2024.

#### **Approve 211 Application for Retirement Waiver:**

Motion made by Trustee Coots, seconded by Trustee Causer to approve Chief of Police to fill out and sign a NYS Retirement 211 Application for a retirement waiver for Officer Zawko. This will allow him to work and make more than the maximum amount as he is retired. All present were in favor and the motion was carried.

#### **NYSDOT Shared Services Agreement:**

Motion made by Trustee Muller, seconded by Trustee Bardeen to approve the NYSDOT shared services agreement for a four year term. All present were in favor and the motion was carried.

#### **Town of Wheeler Fire Agreement:**

Motion made by Trustee Muller, seconded by Trustee Bardeen to approve the Town of Wheeler Fire Agreement for 2024 in the amount of \$6,000. All present were in favor and the motion was carried.

### **Town of Bath Fire Agreement:**

Motion made by Trustee Coots, seconded by Trustee Bardeen to approve the Town of Bath Fire Agreement for 2024 in the amount of \$226,805.13. All present were in favor and the motion was carried.

#### **Town of Bath Lease Agreement:**

Motion made by Trustee Causer, seconded by Trustee Bardeen to approve the Town of Bath Lease Agreement for 2024 in the amount of \$25,000. All present were in favor and the motion was carried.

## **Town of Bath Court Security Agreement:**

Motion made by Trustee Bardeen, seconded by Trustee Causer to approve the Town of Bath Court Security Agreement for 2024 and 2025 in the amount of \$5,500 per year. All present were in favor and the motion was carried.

## Approval of RCAP Solutions Community Agreement, Authorization of Mayor to Sign:

Motion made by Trustee Muller, seconded by Trustee Bardeen to approve the RCAP Solutions Community Agreement for BEGWS and authorize the mayor to sign said agreement. All present were in favor and the motion was carried.

## Mossy Bank SEQRA:

Motion made by Trustee Muller, seconded by Trustee Bardeen that the Village of Bath resolves that the Village of Bath is lead agency for purposes of SEQRA relative to the Mossy Bank Forest Regeneration Project and declares that the project is a Type 1 Action. All present were in favor and the motion was carried.

Motion made by Trustee Bardeen, seconded by Trustee Causer that the Village adopts the findings in a document entitled "State Environmental Quality Review; Negative Declaration; Notice of Determination of Non-Significance"; adopts the Full Environmental Assessment Form Part 2 (Project Impacts) and makes a negative declaration/determination of non-significance with respect to the Mossy Bank Forest Regeneration Project. All present were in favor and the motion was carried.
